1 Apologies

Apologies were received from Cllr E Scott.

2 Minutes of the Previous Meeting

The minutes of the previous meeting held on 21 May 2019 were agreed as a true and accurate record.

3 Audit and Risk Committee Terms of Reference

T Hope outlined the Audit and Risk Committee terms of reference for members information.

4 Audit Completion Report for the year ended 31 March 2019

G Barker presented the audit completion report which summarised the audit conclusions and circulated a letter detailing the conclusion of outstanding matters. Thanks were noted to all staff involved for their cooperation with a challenging process and timetable.

Cllr Lee requested clarity regarding pensions. G Barker confirmed that the pension liability had been increased but this would not affect the level of cash reserves.

5 Statement of Accounts year ended 31 March 2019

ACTION: Members <u>approved</u> the Statement of Accounts for County Durham and Darlington Fire and Rescue Authority for the financial year ended 31 March 2019.

6 Annual Governance Statement 2018/19

10 Internal Audit Charter

S Carter introduced the report to seek approval for the Internal Audit Charter initially agreed in July 2018 to be applied to all reviews undertaken as part of the Internal Audit plan for 2019/20. It was highlighted that no amendments had been made to the Internal Audit Charter.

11 Fraud and Corruption Annual Report

S Carter presented the report which provided advice and assurance to members regarding the work being undertaken within the Authority in seeking to identify, control and prevent fraud and corruption.

ACTION: Members <u>noted</u> the progress made and assurances provided in relation to the Authority's anti-fraud and anti-corruption arrangements.
