

## **County Durham and Darlington Fire and Rescue Service**

At a meeting of the **Performance Committee** held at CDDFRS HQ on **Thursday 10 March 2022** at **1000 hours**.

### **Part A**

#### **1. Appointment of Chair for this meeting**

Cllr Blakey was appointed as new Chair of the Performance Committee.

#### **2. Apologies**

Apologies were received from Cllr C Marshall and Cllr K Rooney

#### **3. Minutes of the previous meeting**

The minutes of the previous meeting held on 9 December were agreed as true record

#### **4. Bonfire Period Update**

Area Manager Keith Wanley presented Members with an update on key outcomes from the Bonfire Period 2021 evaluation. The presentation and report summarised data from the period 25<sup>th</sup> October to 7<sup>th</sup> November 2021 including:

- Calls received and incidents attended
- Deliberate primary fires
- Secondary fires and their locations
- False alarms types
- Attacks on crews
- Firework related incidents

The new plan in place has been a real success. Initiatives including joint patrols with council officers, educating young people and working with Tesco to distribute 5000 leaflets to households through home deliveries. Members of the Committee commended all partners for their support and messaging; helping to keep communities safe during the Bonfire Period

Cllr Quinn asked if the figures are a reflection in the reduced number of organised displays due to COVID. K Wanley explained that through improved messaging incidents have been kept to a minimum. It was noted that firework displays may need to be monitored during the Queen's Jubilee in June.

Cllr Lee noted that the success of this year should be celebrated.

Cllr Manchester queried if the Tesco leaflet drop was a targeted approach in terms of incident hotspot locations. K Wanley agreed to check this to ensure focus is on areas of the County with the highest number of reported incidents.

The Committee **noted** the report and presentation.

### **5. Performance Report Quarter 3 2021/2022**

The organisational performance indicators for quarter three of the 2021/22 financial year were presented to the committee by K Wanley.

The Committee discussed the indicators in turn noting where performance was strong or where additional work was required to secure improvement.

Cllr Lee queried if businesses are charged for repeat false alarms. K Wanley explained there is a process in place to charge businesses if false alarms occur three times within a 12 month period. Less than 5% of premises have been charged due to preventions put in place following the first occurrence.

Fire Safety Audits are carried out and evacuation plans are considered as part of this process. Businesses are required to demonstrate they have sufficient evacuation plans in place although we can only enforce what is part of their building regulations.

Cllr Quinn asked if there are any recorded cases of long COVID within the service. S Helps confirmed there are cases of long COVID and the impact of these will be monitored closely via lung capacity tests for operational staff.

Cllr Lee asked if health care needs identified through the Safe and Well Visits are referred. K Wanley explained that referrals are made to relevant partners if any health care needs are identified.

The committee **noted** the report.

### **6. Letters of Appreciation**

The Committee considered the various letters of appreciation that had been submitted to the Service. In total 19 letters had been received for the quarter three period.

The Committee **noted** the report.
