Purpose of the report

1. The purpose of this report is to provide members with an update of the discussions and recommendations of the Audit and Risk Committee held on 28 September 2017.

Audit Completion Report

2. The Audit Completion report was presented to the committee by Mazars. The audit conclusions were summarised to the members, along with a letter detailing the outcome of matters marked as outstanding. Members were informed that the auditor would be issuing an unqualified opinion on the Statement of Accounts and on the Authority's arrangements for securing value for money.

Final Statement of Accounts Year ended 31 March 2017

3. Members were presented with the final statement of accounts for the financial year ended 31 March 2017. The draft unaudited statement of accounts had been presented to the committee on 27 July where the committee had received a detailed presentation.

The Auditor had now completed his audit, and a number of improvements and amendments had been identified and were included in the final statement of accounts.

Members **approved** the Statement of Accounts for County Durham and Darlington Fire and Rescue Authority for the financial year ended 31 March 2017.

Annual Governance Statement 2017/18

4. Members considered and discussed the Annual Governance Statement (AGS) 2016/17, which reflected the comments made at the July meeting. The approved Annual Governance Statement was to be made available on the Authority's website alongside the Statement of Accounts.

Statement of Assurance 2016/17

5. The Statement of Assurance was presented to the Committee. The final version included reflected any comments made at the July meeting and included significantly more information than previous years.

Internal Audit Progress Report

7. The Committee considered a report which outlined the work undertaken by Internal Audit between 01 April 2017 and 31 March 2018. There was no unplanned work undertaken during the period.
